1. Opening/Welcome

Meeting opened and attendees welcomed by Chairman.

- 3. Business arising from minutes of previous meeting
  - a. Road Fund
    - Presentation done to organisers etc and this is now finalised.

- 6. Agenda items discussed
  - a. Promotions & Partnering
    - DH has been very busy and done a great job of activating the FB page.
    - MTA is now showing interest and DH is continuing discussions.
  - b. Birdwood NMM SA Rally Presence
    - AA and DA met with Mathew Lombard (curator) to discuss possibility of displaying perpetual trophies at NMM.
      - $\circ$   $% \left( A_{1}^{2}\right) =0$  Mathew is not the person who will make the decision, but he saw some merit in the idea.
      - Display would need to include a car with a story. Important the display is kept fresh so car would need to be rotated each 6 to 12 months.
      - If multiple disciplines involved, then different car from each discipline for 6 or 12 months.
      - Potential to utilise existing area put aside for motor sport which is an excellent location.
      - Important that the proposal show we have thought through issues such as administration.
    - Need to consider if we approach as SARP only or as MA State Council (to include one or more other disciplines). Will depend on interest from other disciplines – and how many trophies they have.
    - AA to raise at State Council.
    - All agreed that SARP is happy to proceed alone if no other interest.
    - DA/AA to email initial draft proposal to NMM by end of this week.
  - c. Door Panels
    - DH presented design for new SARP door panels.
    - All agreed QR codes should go to SARP Facebook page and Officials Facebook page.
    - DH to finalise and send artwork to printers by the end of this week.
  - d. Panel Members
    - All were happy with the number and make-up of the panel.
    - DA suggested review at the end of the year to identify members not attending many meetings to potentially be replaced by new members in future.
  - e. Website Update
    - Web site is looking good. information is up-to-date and quite easy to find.
  - f. Entry-level Rally Car project
    - Hold over to future meeting.
- 7. Reports
  - a. Checker
    - Supp reg's received from MA for Walky100 however unable to respond to MA within the 48-hour window provided.
    - Generally OK apart from need some clarity around possible night stages for Regularity.
    - SA Regularity Series Sporting Regulations say that "organisers are encouraged to have at least 50% daylight stages" which implies night stages are not an issue. No mention in MA NRSR Regularity regulations.
    - Concerns raised that first 3 stages will be timed but not scored. MA Regularity Regulations say that "any reconnaissance is not permitted" and this could be considered as reconnaissance. JA to review and advise.

  - DA to ask MA for an explanation of the GST treatment of the Funds in writing so that we have something on record for the future.
  - DA asked how MA know which events to charge for Trophy Fund. MA should be aware from Conditions of Rallying however agreed that DA should communicate events to MA to be sure.
